STATEMENT OF FACT: I have read the Beacon Hill Preparatory School, (BHPS), Parent/Student Handbook and will comply with all the rules and regulations set forth in the BHPS Parent/Student Handbook (which is available online at www.BeaconHillMiami.com). The BHPS Parent/Student handbook includes our policies for dress code, discipline, technology use, and expulsion. The following is a segment of the BHPS Teacher/Student Handbook:

CHILD DISCIPLINE: (A) Minimum standards for child discipline practices shall ensure that age appropriate, constructive

disciplinary practices are used for children in care. Such standards shall include at least the following requirements; (1) Children shall not be subjected to discipline which is severe, humiliating, or frightening. (2) Discipline shall not be associated with food, rest, or toileting. (3) Spanking or any other form of physical punishment is prohibited. (B) Prior to admission of a child to a child care facility, the facility shall notify the parent in writing of the disciplinary practices used by the facility (This may be located in the Parent/Student Handbook on the BHPS website, www.BeaconHillMiami.com)

ADMISSION OF MEDICATION: Parent/Guardian is responsible to demonstrate the admission of medication to the day care provider in the office.

IMPORTANT INFORMATION FROM THE DEPARTMENT OF CHILDREN AND FAMILIES: Section 65C-22.006 (2), F.A.C., requires a current physical examination (Form 3040) and immunization record (Form 680 or 681) within 30 days of enrollment. Section 402.3125 (5), F.S. requires that parents receive a copy of the Child Care Facility Brochure, "Know Your Child Care Facility" (CF/PI 175-24, or Section 65C-20.11 (2)(c)(1), F.A.C., requires that parent(s) receive a copy of the family day care home brochure, "Selecting A Family Day Care Home Provider" (CF/PI 175-28). Section 65C22.006(3)c)2., F.A.C., requires that parents are notified in writing of the disciplinary practices used by the child care facility, or Section 65C-20.010(6)®, F.A.C., requires that a written copy of the family day care provider's discipline policy be available for review by the parent(s).
